**Description:** The issue involves the positive battery cable connection to the fuse box which, over time, could become damaged and lead to a no-start condition, or momentary flickering of the instrument cluster.

In an extreme case, engine stalling and loss of electrical systems could occur, increasing the risk of a crash.

**Remedy:** The positive battery cable connector will be replaced with an improved version, and the cable will be secured to the fuse box.

# **CARFAX** Glossary

## **First Owner**

When the first owner(s) obtains a title from a Department of Motor Vehicles as proof of ownership.

## **Manufacturer Recall**

Automobile manufacturers issue recall notices to inform vehicle owners of a safety defect or failure to meet minimum federal safety or emissions standards. Manufacturer recalls are repaired at no cost to the customer.

#### **New Owner Reported**

When a vehicle is sold to a new owner, the Title must be transferred to the new owner(s) at a Department of Motor Vehicles.

#### **Ownership History**

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico. Dealers sometimes opt to take ownership of a vehicle and are required to in the following states: Maine, Massachusetts, New Jersey, Ohio, Oklahoma, Pennsylvania and South Dakota. Please consider this as you review a vehicle's estimated ownership history.
